महत्वपूर्ण अनुदेश

- 1. वर्ष 2017—18 के दौरान सीखो और कमाओ योजना के लिए पिरयोजना कार्यान्वयनकर्ता एजेंसियों (पीआईए) को पैनल में शामिल करने के लिए प्रस्ताव आमंत्रित करने हेतु 9 सितंबर, 2017 को राष्ट्रीय दैनिक समाचार—पत्र में जारी विज्ञापन के अनुक्रम में अल्पसंख्यक कार्य मंत्रालय ऐसे प्रशिक्षण भागीदारों (टीपी) से नए सिरे से प्रस्ताव आमंत्रित करता है जिनके पास स्मार्ट प्रत्यायित एवं संबद्ध प्रशिक्षण केंद्र (टीसी) हैं / अथवा वर्ष 2017—18 के दौरान "सीखो और कमाओ" योजना के अधीन राष्ट्रीय कौशल अर्हता ढांचे (एनएसक्यूएफ) के अनुरूप प्रशिक्षण संचालित करने के लिए अपने प्रशिक्षण केंद्रों को राष्ट्रीय कौशल विकास निगम (एनएसडीसी) के स्मार्ट पोर्टल के माध्यम से प्रत्यायित एवं संबद्ध कराने के इच्छुक हैं।
- 2. अल्पसंख्यक कार्य मंत्रालय की सीखो और कमाओ योजना को कार्यान्वित कर रही परियोजना कार्यान्वयनकर्ता एजेंसियां (पीआईए) तथा जिनके पास उक्त टीसी दर्जा प्राप्त है, भी आवेदन करने के लिए आमंत्रित हैं। विस्तृत जानकारी के लिए, इच्छुक एवं पात्र संगठन मंत्रालय की शासकीय वेबसाइट http://www.minorityaffairs.gov.in देख सकते हैं। जहां आवश्यक अनुदेश और संशोधित आवेदन प्रपन्न संलग्न किए गए हैं।
- 3. प्रशिक्षण केन्द्र—प्रशिक्षण भागीदार अल्पसंख्यक कार्य मंत्रालय के एनजीओ पोर्टल पर ऑनलाइन प्रस्ताव भेजेंगे और डाक द्वारा भी निदेशक (कौशल), 11वां तल, पं. दीनदयाल अंत्योदय भवन, सीजीओ परिसर, लोधी रोड, नई दिल्ली—110003 को भेजेंगे। चूंिक अल्पसंख्यक कार्य मंत्रालय का एनजीओ पोर्टल तैयार हो रहा है, अतः पात्र संगठन हार्ड प्रति भेज सकते हैं और जब एनजीओ पोर्टल चालू हो जाएगा तो उसके माध्यम से भी भेज दिया जाए।
- 4. परियोजना कार्यान्वयनकर्ता एजेंसियों (पीआईए) को नीति आयोग के एनजीओ दर्पण पोर्टल पर पंजीकृत होना चाहिए।
- 5. **सीखो और कमाओ के पूर्ववर्ती आवेदन प्रपत्र को रद्द समझा जाए।** सभी पीआईए जिन्होंने पूर्ववर्ती प्रपत्र ने आवेदन किया था, **नए सिरे से संशोधित प्रपत्र** में एनजीओ पोर्टल (जब यह चालू हो जाए) के साथ—साथ हार्ड कॉपी में भी आवेदन करें।

Important note for PIAs:

Please note that TC of PIAs has to enter into mutually exclusive agreement with Ministry of Minority Affairs where a written undertaking would require to be furnished stating that TCs will not train under any other scheme other than 'Seekho aur Kamao', once the targets are allocated.. This implies if PIA is running training under any other Government scheme (e.g PMKVY) then PIA cannot undertake any trainings under 'Seekho aur Kamao' scheme at the same centers at the same time and vice versa. Please note MoMA can at its discretion undertake surprise monitoring and if any PIA is found flouting with aforementioned guidelines then MoMA reserves full right to take any action leading to cancellation of PIA's registration, withheld payments, blacklist their centers and revoke their targets.

It is further to be noted that no candidate can undergo training in same trade twice from two different schemes. Undertaking may be taken from the candidates and the PIA AS WELL, in this regard. Hence it is the responsibility of PIA to ensure no such duplication should take place. MoMA reserves full right to take any action against PIA if such cases are found.

Estimation of Target allocation:

The targets to PIA's shall be allocated based on their average annual turnover. The formula for estimation of targets is as follows:

Maximum number of target allocation to that entity = $\underline{\text{Average annual turnover for past 3 years x 4}}$ Per candidate cost proposed

However, MoMA, at its discretion can consider additional or deduct allocation based on the performance of the PIAs who have successful track record in the past in the implementation of either scheme of MoMA or any other Government organization.
